As to 285:

The lawyer for Louis Bechtel (the former fed judge who is the receiver) who is in the same law firm as Bechtel asked for an extension until Monday. I agreed to that extension. His reason was that Bechtel was "in and out of town" but that he (the lawyer) had sent the contract "approved as to form" and it was up to Bechtel to decide about the price. I think that means the \$1.25 million offered is more than the two-thirds minimum but he would not say that. This is all according to Cara Coniglio who has the listing. She seemed encouraged.
