The PCI assessment identified a vulnerability point because credit card information entered at the property level into Skyware is done from a keyboard which is non-encrypted & vulnerable to being hacked.

Attached are the for the recommended device to gain compliance, it looks like the cost on them is about \$175 each. My suggestion is 3 devices – front desk, GM office and accounting office.

Please let me know how you'd like to proceed and I will work with Sorbis to source and install.
