Noam,

I spoke with Harry a short while ago and made no progress whatsoever. In fact he refused to give me any input into his thoughts at all, except that he would be willing to speak about the successor=trustee issue with either Max or his own counsel on the phone. I got the distinct impression that he has made=little progress on finding his own counsel as he mentioned that a discussi=n with his own counsel would need to wait until January.

I asked Harry to consider naming Richard as the successor trustee on the basis that Richard is a trustee with a great deal of e=perience, he has your trust, and he is a permitted independent trustee acc=rding to the terms of the trust.

If we are to make progress on finding a successor to=Max we need to either a) have a call with Max and Harry early next week; b= your daughters need to agree to remove both Max and Harry and leave the a=pointment up to you; or c) institute a court action for removal. I do not think we should wait until Harr= finds his own counsel. I do not think we should institute a court a=tion until we get the list of potential successor trustees from Max and ha=e had a chance to review it together. I will review and share with you, Valeria and Richard the list of potential =successor trustees from Max and we can determine how to proceed from there.=u>
