Stay =t the Mayan Inn. See the churches and shop bargains!) 4. Lake Atitlan, = 1,600 ft. deep lake in the mouth of an extinct volcano with Indian villag=s, accessible only by boat, around it. (Stay at Hotel Casa Palopo.)
