- =nbsp;The last week of October,(Gary Kerny's final week) the instruction =o order the plants was given, by Mr.Epstein and Gary =erny.

- =nbsp;By the Second week of November(11/7-11/11) All the material was =ourced and centralized for shipping, and the Invoice sent for =ayment.

***Eventhough payment had not been Made, as a personal favor =o me the shipment was put in motion, since I had relayed my orders to =ave the material on LSJ, ASAP.

The Goal was to have the sod And the other plant material =rrive at the same Time: =nbsp;Saturday 11/19

-Tuesday =1/15

Mr.Epstein, cancelled the order, which was already in =transit.

So The =aterial was Returned to the farms that it came from, and the Vendor was upset, due =o the waste of time and energy to load, and now Unload the =aterial.

-Later Mr. Epstein told me to still get everyrhing except =he ixora.

-When I requested that, I was told, it may be possible to =et it sent on the following shipment the following week, however the =aterial was already returned, and a new order needed to be =enerated

- I was told due to the Holidays, I would have to =ait until After the Thanksgiving Holiday/Vacation to process that "new" =rder

-When I =egan to explain all of this,

During the Wednesday 11/23 Morning Meeting with Tom Melnik, Brice =ordon, [REDACTED], Mr.Epstein told me not to ever mention the order =gain, because Ixora's are a

-Today I received the new invoice which had a few mistakes on it, and I =eturned it to be corrected.

I expect that to come back =omorrow.

At that point 50% of the total invoice must be paid, before =he shipment moves.
