The withdrawal from th= IRA for taxes and management fees for the entire estate was just done.♦=A0 There are even stronger reasons to keep to that procedure in the presen= case, since I am simply asking for tax payments from funds that I should have full access to.

Doesn't seem to me that anything is needed beyon= that.
