I wrote Harry a strong letter say that =he matter was indeed urgent and shouldn't be delayed, and asked him to =lease arrange the call as quickly as possible. The urgency has to do with the taxes, and there is no =eason for Max or Harry to have any elaborate explanation of why we need =he money.

When money was being withdrawn regularly =rom my IRA to pay taxes and management fees for the entire estate, =either Max nor anyone else asked for an explanation or a financial =eview of the beneficiaries, or any account of how money from the trusts =as being used (not for or by me). The withdrawal from the IRA for =axes and management fees for the entire estate was just done. =here are even stronger reasons to keep to that procedure in the present =ase, since I am simply asking for tax payments from funds that I should =ave full access to.

Doesn't seem to me that anything is needed beyond that.
