Dear Noam,

Richard has requested that I request from Max \$150,000 for 2017 estimated federal tax payments. He has not provided me with a Massachusetts figure that he wants me to request. Nick Nichols has advised that if the estimates for 2017 are paid from your IRA, four figure tax penalties may be avoided. Of course a distribution from the IRA will incur a tax itself; therefore Nick also advises that he should calculate the balance between the IRA and non-IRA assets (i.e. the marital trust) to pay the estimates. Please see Nick's email of 12/5/17 at 1:11 p.m.

Please confirm that you want me to follow Richard's instruction that a \$150,000 distribution should be taken from the marital trusts to pay your 2017 estimates, and that you do not want to follow Nick's advice that the estimate be taken from your IRA and the marital trust in some proportion that Nick needs to calculate to avoid penalties and minimize income taxes. If you do want to follow Nick's advice I will follow-up with him.

Richard has requested that Max distribute an amount to you from the trusts of the amounts paid for your 2016 income taxes from your IRA and for the penalties you incurred for tax year 2016. According to the information I have received from Matthew Mazotas this amount is \$109,271. Please confirm that you want me to request this distribution from the trust from Max.

Please note that you and Valeria are my clients, and I cannot take direction from Richard with respect to your personal income tax matters without confirming the action with you first. I am working as fast as I can within the parameters of my duty to you which is paramount in all matters.
