currently we have 18kw which is suffic=ent to run 9 ac units at once at they draw 1-2kw each but insufficient to  
=un old RO that currently does not work..

gen=rator is not needed to charge batteries however it is necessary when we ha=e cloudy days..

pro solar is also trying to=source a new generator for us and we need an RO solution (i still like con=ainerized  
units 250-300k depending on size)

pro solar presented = generator option a few weeks ago however that unit was restricted to BVI =nd could not  
be sold to USVI

generator and ro are=next key items to get into place..

jimmy so far has been unhelpf=l with this and i have no trust in danny who i think is the main cause of =he  
generator / ro issues on LSJ..
