The use of your foundation funds on the event =as my call. When I met you a year or so ago and you offered 100K =o support my work, Giuseppe was looking for sponsorship for the Cuba =onference. I asked you to support the conference as expenditure =f the 100K that you granted to me. It is the only monies that I =ave spent other than the 3K or so I spent on the Vive system I got for =ou (which still has not yet been installed at your place). =nbsp;

Over =he past year, I have been working on a research agenda that would =nterest you and further the work that I am developing. Over the =ast year, I have been developing and applying a theory of =development. I have attached the slides to this theory and there =s a short summary of it here; https://photos.google.com/share/AF1QipOBQa4z8TRJ7B0XwvassIgeBXpB7rmnXAs3FZQyuVQx8w2Hpze3yG_Iqp2wNSfFLA?key=RGR3MGNYaW1LSTZMX2RaSzJIR2RjQIZQaUxQTE5R. I also walked you =through this theory via our Skype conversation a few months back (when =he hurricane hit). I have introduced you to a few people who have =nteresting abilities including David Sauvage, Noah Berman, Paul Selig, =nd Edd Edwards. I still don't know what the issue you have with Edd =s.

I =m also putting together a number of researchers to study people once =dentified. In New York, these include Ray Lee and Zoran Josipovic =ho you have not yet met. Others I've assembled include =hin Lin (<http://mindbodylab.bio.uci.edu/> <<http://mindbodylab.bio.uci.edu/>>), Brown =sieh (<https://www.duke-nus.edu.sg/content/hsieh-po-jang-brown>), and I am giving talks in =aiwan and China next week to recruit more. I am also seeing =eaders of Qi Gong research in China on the 14-15 in Beijing. =nbsp;

I am =lso collecting new "researchers" and "special =bilities subjects" with tours I am planning this year. =he first is in January in Europe (<https://www.evolvingcaravan.com/>). = am planning the US in May / June, and Asia in October. This tour =s to also help stage 3 people, people who have had an awakening =xperience, but are not grounded. Many of these people end up in =ental hospitals or homeless. The community of "special =bilities subjects" are particularly effective at helping to =E2◆◆ground" these "stage 3" people. =e also have practices that

enable them to better function in the modern world. This is how I was planning to use the remainder of the funds that you allocated. I started talking to you about it before was cut short by Ehud.

As an example of how my model and practise can be applied, Joe Pagano Jr. is one of the subjects that is a success story." When I met him, he was ungrounded. He is now grounded and has developed the ability of deep presence. He also has a community of people that he can engage. I also have, if you still recall, a proposition on the table to you regarding helping unhappy wealthy people find inner happiness.

When you allocated the funds, I asked you specifically what the "deliverables" were, to which you left it entirely up to me. My purchase of a Vive for you is to open you up to the world of Virtual Reality. With the transfer of the remaining funds, I was also going to get you the music player that I showed you when we last met, filled with my music library. These, and all of the people I brought to see you at my expense, have all been 'deliverables' toward introducing you to new perspectives and experiences. I really enjoy our meetings. It seemed to me that you enjoyed them as well.
