We've been trying to figure out the =atter of the distributions from the Marital Trust. We received no =otice of this from Max. It seems, from what you say here, that the =istributions would have gone directly to the Treasury, for taxes. =n order to keep our records straight, we contacted Nick almost 3 weeks =go to find out what the full tax bill was and how much we actually =aid, assuming that the distribution must have paid the rest. But =e have not heard from him.

So at the moment it's unclear just what happened with =hese distributions from the Marital Trust.

On the distributions to the =randchildren, at least in 2016 I have no record of even being =onsulted, and have no record of any formal authorization for earlier =ears.

In case I hadn't made it clear before, yes, please do =eep Richard Kahn copied.

Dear Noam,

The distributions that =ere made for taxes in 2015 and 2016 were to pay your and Valeria'= estimated income taxes for tax year 2015. These were the =istributions that I succeeded in getting Max to agree to make from the =arital Trusts as I was disturbed at the time, and still am, by the fact =hat distributions for your and Valeria's lifestyle and all =ncome tax payments were being made from your IRA and subjected to a =uch high level of taxation than necessary, thus unnecessarily running =own the IRA funds, considering that your funds in the Marital Trusts =ere available for your needs.

With regard to the gifts to your children =nd grandchildren, according to Max's summary distributions to =our Charitable Gift Fund, to your children, to your grandchildren, and =o the Chomsky Grandchildren's Trust were made from January 12, =010 through January 13, 2016. Since you are the only =eneficiary of the Marital Trusts (this is a legal requirement) these =ould be considered gifts from you, and as such you would have had to =ave given Max permission or direction to make these =istributions.

I hope this is helpful. Do you want me to keep Richard Kahn copied on our correspondence? You could be waiving attorney client privilege as we have discussed and I am concerned that he and I will be working inefficiently if we are both not copied on all emails regarding your and Valeria's financial affairs. Please let me know as I think his input is helpful. I am not copying him on replies to you where you have not copied him on our initial email to me, hence my question.
