=div dir="ltr">We've been trying to figure out the matter of the distributions from the Marital Trust. We received no notice of this from Max. It seems, from what you say here, that the distributions would have gone directly to the Treasury, for taxes. In order to keep our records straight, we contacted Nick almost 3 weeks ago to find out what the full tax bill was and how much we actually paid, assuming that the distribution must have paid the rest. But we have not heard from him.

<=i>So at the moment it's unclear just what happened with these distributions from the Marital Trust.

On the distributions to the grandchildren, at least in 2016 I have no record of even being consulted, and have no record of any formal authorization for earlier years.</=i>

In case I hadn't made it clear before, yes, please do keep Richard Kahn copied.

The distributions that were made for taxes in 2015 and 2016 were to pay your and Valeria's estimated income taxes for tax year 2015. These were the distributions that I succeeded in getting Max to agree to make from the Marital Trusts as I was disturbed at the time, and still am, by the fact that distributions for your and Valeria's lifestyle and all income tax payments were being made from your IRA and subjected to a much high level of taxation than necessary, thus unnecessarily running down the IRA funds, considering that your funds in the Marital Trusts were available for your needs.

With regard to the gifts to your children and grandchildren, according to Max's summary distributions to your Charitable Gift Fund, to your children, to your grandchildren, and to the Chomsky Grandchildren's Trust were made from January 12, 2010 through January 13, 2016. Since you are the only beneficiary of the Marital Trusts (this is a legal requirement) these would be considered gifts from you, and as such you would have had to have given Max permission or direction to make these distributions.

I hope this is helpful.=C2◆ Noam do you want me to keep Richard Kahn copied on our correspondence? You would be waiving attorney client privilege as we have discussed and I am concerned that he and I will be working inefficiently if we are both not copied on all emails regarding your and Valeria's financial affairs. Please let me know as I think his input is helpful. I am not copying him on replies to you where you have not copied him on your initial email to me, hence my question.</=>
