As of today, a crew is working on=the Cabrita Road laying the poles near the beach at the Ritz (near LSJ ac=ess point). They explained that they are moving slower than u=ual as land is below sea level and they need additional equipment to secur= the poles in the sand. He estimated 10 to 14 days before the poles =re completed out to the end of the point. And a number of days=later to pull the wire - but in his words this was a very rough esti=ate . He did say as soon as we see the wires being pulled they=are getting close to energizing.
