We were surprised to learn that Rich Kahn raised questions about outstanding invoices. =A0 We did not mention this to him (or to anyone), as it would be totally inappropriate. However the main reason why the invoices remain outstanding is a combination of factors: our intense schedule that has been even more intense than usual in the last months; we would like to better understand what is being charged, since we don't remember having discussed, requested or being informed about some items in the invoice. Among other things is the lack of information about exchanges with Max that we haven't been copied or informed about, or received any of the copies as we had requested.

You mentioned in your letter of August 31 that it was a top priority to send us the drafts, but we have not yet received them.
