I apologize but I overstated the returns. The Sept M=rrill account statement was wrong and understated the account by \$2.5MM (they duplicated a debit to pay for a structured note and the cash was sitting in a settlement account which is not included on the statement). So I used a starting account balance that was too low. This was corrected in October.

Corrected:

1st Oct Starting Account value (ex apple)= =C2♦ \$170.28MM

Current Account value (ex apple): =C2♦ =A0 \$171.=MM

Change \$1.320MM or 0.78%
