I now have confirmation from Fallani that the two boys indeed came from him. Sadly, he has no documentation from the 1960s so there isn't proof. 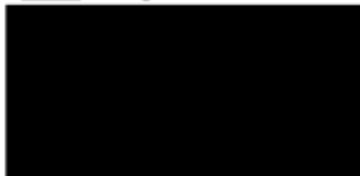
