Wiring from the projector to the equipment rack could possibly take two men a full day and may require cutting holes in the ceiling. I cannot absorb that cost. If you like I will requote with the worst case scenario providing ample cost for rewiring. Patching and painting will not be included.

We were not involved in the original installation and have no knowledge of the existing wiring pathway/conduit. If there is a conduit in place and the wires can easily be pulled through then that would mitigate the scenario above. It would still require additional time.
