Hello Sir,

There's lots of emails going around — some with incorrect information — so I thought it'd be good to recap the status of each house.

NYC / 71st:

Receiver: Marantz AV7005 does NOT support 4K passthrough

Projector: Epson LS10000 is 4K HDR compatible

Cables: uncertain, assuming not 4K

Zorro:

Receiver: McIntosh MX121AV does NOT support 4K passthrough

Projector: Epson LS10000 is 4K HDR compatible

I'd suggest sending an Apple TV 4K down to Palm Beach to replace their existing Apple TV and seeing if it works as expected.

If it does, consider the Marantz SR7009
