We are pushing for ISDA finalization today, but not there yet. Darren has been great - very responsive.

(1) MXN - as you probably saw, Mexico's central bank cut its overnight rate by 25bps to 3.50% vs. market expectations of a 40bps cut. The peso rallied vs the dollar ~0.9% to 12.834 (~12.86 last). Clearly reflects in our pending deposit plus position (updated levels below). Still like it despite the move.
