Basically Phil was on the phone with Josh and Bernard Saint- Donat ...he said he got some accounting? I never saw anything. He said Gary's accounting was weird but the thought somewhat accurate.

He gave me the impression he felt he had done me a great service getting Gary's initial offer of \$5,000 up to \$50,000 and that was the best he could do...and to split rest of the 400,000 in half and call it a day.

Phil had brought to Gary's attorney's attention a New Jersey law about how much it would cost if we asked for a financial accounting....

And it didn't pay, time and money wise to sue Gary. I would spend at least 25,000 in Phil's fees plus the estate would have to pay for the state accounting...blah, blah, blah.

That is what the studios come to me for as he also takes a large piece of my fee for competing with me. When I asked him not to invite academy members from sept.-jan he got hysterical.

I currently have a very nice calm working relationship with him...although he gets testy when asked to change a plane reservation. Josh says I need a travel agent.

He whined about firing someone today...saying it was not his job. Trying to figure out what it his job....and to prove his weirdness...he never laid eyes on Jenna Friedman in the one year she worked there... this is a real sickness....to "run" a company from his apartment and never ever come to one event or look any employee in the eye.

I am very slowly and calming moving on.
