Hi Max,

I'm sorry my recollection differs from yours re the Mass estimate. I have a clear recollection of discussing it with you and coming away from that discussion under the distinct impression that if they decided to pay a Massachusetts estimate you were amenable to adding it to the current federal payment. I communicated this to Noam as well. This approach made sense in our discussion as it is consistent to pay a Mass and federal estimate at the same time. I cannot speak for the lack of payments earlier this year but if you could see your way clear to accommodating this much

smaller tax payment distribution as well=under the same theory as the one applied to the federal estimate I would be=very appreciative.

In your prior reques=s and in our conversation on Monday no mention was made of paying estimated=Massachusetts taxes – only federal tax payments were discussed. When I received the federal tax voucher from=Matt I noted that in the comments section of the voucher he recommended to N=am and Valeria that they make a MA payment, but I confirmed with Matt this m=rning that his message was addressed to them, not to me. I have at no time agreed to make an estimated pay=ent to MA and doing so would not be consistent with what I believe we agree= upon in our call on Monday (i.e. no further distributions of principal wit=out some reasonable disclosure).

It is dismaying to lear= that no federal or MA estimated taxes were paid by Noam and Valeria in 2017, a= well as to hear from Matt that Noam and Valeria have not been responsive t= Matt or Nick when they've attempted to address tax planning with N=am and Valeria over the course of the year.

I have confirmed with B=inco that the federal voucher and payment were mailed to the IRS today.

Has there been a decision made about the state estimated tax payment=

Since the new tax bill has just passed, the federal deduction for state income tax and real estate tax payments will be limited to \$10,000. An estimated state tax payment should be made in 2017 to capture this valuable federal deduction while it is still available. This payment needs to be made before December 31st!<=:p>

Based on rough projections, a \$30,000 estimated payment to Massachusetts would save about \$10,000 in 2017 federal tax.

Max, attached please find the requested 2017 Q4 Federal Estimated Tax Voucher for the Chomsky's.

Please be aware that in raising cash to make this payment from the trust, it may create income that might be taxed to Noam due to the trust distribution.

A state estimated tax payment should be made in 2017 to take advantage of the deduction for state tax payments. This deduction will be severely limited if the new tax bill is enacted. Please advise on an amount that the Chomsky's would like to pay in order to take advantage of this deduction. We had recommended \$30,000 when we prepared their 2016 return, based on safe harbor amounts.
