2015 the Well Pump for Well B was upgraded to 50 gpm 3 phase motor, in doing so a single phase to 7.5hp 3 phase VFD was installed.

The existing drive is very susceptible to voltage fluctuation and as of date the VFD needs to be reset frequently during the day.

This situation is making it very difficult to achieve a constant water supply for domestic and irrigation purposes. It will need to be addressed if we are to achieve the quantity of water required under the permit E 7871. =C2♦

RMC Electric sourced the company that will supply the drive and provide support

The new drive is 25hp vs the existing 7.7hp drive, this will handle the power fluctuations from the power company.
