Aug SPY 280 calls at \$3.05 (we paid \$1.55). The SP500 is bumping up against 2800 which has been a big resistance level this year. If it breaks above 2800 I think we could test 2840 in short order. So I am looking at the following:

- * Sell 350 contracts of the Aug 280 SPY calls for \$3.05
- * Buy 350 contracts of the Aug 284 SPY calls for \$1.27
- * Take \$1.78 off the table and be well positioned if we break above 2800.<=u>
