If you wish to keep your existing windowline fabric, then you should go with either the same fabric for the LSU's and headliner or all ultrasuede.

What I prefer is to replace the window line fabric with the Dedar (tightly woven and contemporary) fabric with either the stria ultrasuede for the headliner and upper valance or if you do not like the faint lines in the stria, a plain ultrasuede. I like having a slight texture.

The Romo was another great choice for the window line fabric - "slightly" less modern and no sheen.

Look at windowline fabrics in the vertical position- NOT laying flat on the table.
