For example, e-mail from the three children -- Avi, Liane and Harry on Feb 6, 2018 at 9:16am:

On a personal level, we are heartbroken to feel that we are kept at such a distance from you in your new life. We were thrilled to learn that you had found a new partner, but we were grieved when we began to realize that this meant we are rarely able to see you. Even email and telephone communication has become much more limited. We have also been increasingly distressed to see that instead of feeling happy and relaxed, you feel impoverished. You have even felt the need to hire multiple lawyers to threaten people who you had trusted for years, and who we believe have continued to do their utmost to act in your best interest and to help you navigate your new financial situation.

We have in fact found your letters over the past year increasingly alarming. If we felt that you were stable and content in your new life, we would probably accept the distance that has been created. But your statements, in person, and in your letters, do not give us the impression that you feel stable and content."=div>

Here are the undeniable attempts of laying the fundamentals for a claim of undue influence and alienation of an elderly.
=A0 This is outrageously false.

Or statements about Noam in family's conversations: "Being intellectually active doesn't mean capable of making decisions".

Or a previous maid calling me to ask why I was not allowing the children to visit their father, as she heard from one of the daughters who told her that she had never been in the apartment, when in reality she had been there many times, by herself and with her family.

For me, there are many more important things than money.=C2 And I am not selling my values and principles for whatever amount.=C2 They can keep the money for themselves. If Noam wants to put money aside for me, that's his decision.

Some of these points might seem irrelevant, but I think the children's behavior has been showing a clear attempt to build a case for elderly abuse. Hence the need of answering all the aspects of the petition, including the innuendo.
