Yes=Sir I thought about that. I know we have had issues with PSI and the=mix designs of the concrete. I do have experience pouring up to 1400=yards a day (24 hour shift) so I can oversee this directly to make sure it= done right. We have a few options here;

- = will operate the machine (temporarily) until I can train an o=erator we can trust (its as complex as running a grain combine just need t= track weights and do simple math)

- Purchase a p=oduct like Vita-Concrete - this has portland cement / sand / agg all mixed=in we just break bags and add water and I can calculate how many lbs we ne=d to order before pours

- Vita has premade =ix designs up to 5000 psi and if we need more (dont think we will) then we=can use additives like fly ash to up the psi
