Moreover, my behavior, and its implications for others, was strongly distorted and/or misrepresented.

I also changed =his by adding ASU.. since it is the ASU claims that didn't =rise till after..

To the extent that this may have caused any concerns among some individuals =t ASU— concerns that I stress were never relayed to me or to the University during my time at ASU until after a tabloid =rticle appeared about me
