Thank you for asking me t= serve as the trustee of the marital trusts. After careful considera=ion, I unfortunately believe my present position as your and Valeria's estate planning counsel prevents me from accepting this =dditional role. In taking on the trusteeship, it is my view th=t although your interests would take priority, I would also need to consid=r your children's interests as the remainder beneficiaries. In working with and getting to know you and Valeria over the last few year=, my understanding of the situation is that this conflict of interest make= taking on both roles untenable in this instance, especially where one of =our children is the current trustee. I anticipate Harry would not agree to appoint me in any event, given=the hostile nature of his approach during our discussion last week, and as=he knows that I am currently advocating exclusively for your personal inte=ests. I believe that at the present time, Valeria's and your interests are best served by keeping me i= my current role, and finding another qualified and trusted advisor to ser=e as the trustee of the marital trusts free of any perceived conflict of i=terests.

I understand that you wou=d like to achieve the change in trusteeship sooner rather than later. =A0 I spoke with Max yesterday afternoon to ascertain what documentation he needs in order to make the additional principal distributions you have =equested, per your and Richard's direction, and we also addressed =he successor trustee list he is preparing.
