#### Fwd L/H Bulkhead Monitor Closeout

Fabricate wood handle and finish to replace existing clear vinyl tab

#### Fwd R/H Cabin Bulkhead

Fabricate temporary cover for Exit Sign in wood veneer to complement existing

#### Fwd Cabin Pocket Door

Camouflage door handle and create visual symmetry of seam(s). Fabricate rectangle veneer with top of piece at same elevation as top of L/H bulkhead monitor opening. Lower horizontal line could be at top of seat back height. Overall width approx. 5.0"

#### Mid Cabin Curtain

Fabricate new one? Sew vertical seams in existing to help minimize the wrinkles at the bottom? Need additional retaining strip with metal plated snaps.

#### Monitor on Ledge

New monitor (in the color black) with swing arm mounted to ledge?

#### Speaker Bar

Mounted above side duct outboard of lower side panel? Incorporate speaker grill to allow acoustic transmissivity?

## Sub-Woofers

What are we doing with Carry On sub-woofer?

## Divan Arm rests

Add (.50" ?) foam to inboard vertical and top of arms (to be "softer")

## Divan "Carry On" mattress

Reupholster in new fabric (Crate & Barrel fabric?)

## Aft Galley / Lavatory door

Replace double stick tape with contact adhesive on wood veneer closeout for horizontal piece.

## Aft R/H Galley

Replace double stick tape with contact adhesive on wood veneer closeout for aft bulkhead piece.

## Aft Lavatory Potty Seat

Cut and sew white fabric pad in half

## Aft Lavatory Toilet Paper Door

Work "garage door" so that it is more stable when being open or closed

## Aft L/H Galley

Replace existing LED lights with new both inside the glass rack compartment and underneath that illuminates the countertop.

## Aft Galley

Fabricate inserts to contain customer supplied carry on items.

Foot Stool

Fabricate a second foot stool (covered in carpet to match the existing) so that they both fit into the existing "bag dock" on the L/H mid cabin

Sidewall Table Pulls

Hard edges are uncomfortable against fingers. Cover edge in leather / rubber / trim this piece for comfort

Aft Lavatory Door

"Hinge" on door makes noise
