In any event, the =ediation will begin with all parties and counsel joining to hear a =essage from the mediator about the benefits of settling the matter. =nbsp;The lawyers and the mediator will be in a conference room and the =parties will participate by Skype or similar hookup. The joint =ession is usually brief. Then the lawyers and their respective clients =reak out into separate rooms and the mediator meets with one side first =nd then the other side, conveying proposals until the case either =settles or it is determined that the case will not settle. Richard =an listen to the mediator's introductory remarks and he can =articipate in the discussion in "our room" during the =uttle diplomacy of the mediator, as well as any discussions I have =ith you and Valeria during the mediation. Ordinarily non-lawyers do not =therwise participate, for example, if there are direct discussions =mong counsel.
