Thus, I think I will need another 60K for covering expenses. =owever, the bigger issue may be taxes for 2018. I don't know =ow we can book the money I received directly (i.e. not via Humanity =lus), and how to deal with the taxes for that, and I don't have =ny funds to cover the taxes I owe for 2018 (including the tax for the =dditional 60K). Ideally, we should sort this out this month, please!
