I =ill ask for compensatory damages. Should I indicate what =amages? If so, funds to meet with and obtain materials from those =ho I have been forbidden from meeting, funds to access information that = have not been able to access by being at the University when I have =anted to be there.. Anything else?

I will emphasize the pack and ship =hing more strongly.
