Thanks.. these are good points.. re the use of funds.. they have allowed me to use my funds to go to the University to carry out tasks, like cleaning my office, meeting with committee members, even during the period of administrative leave.. Thus, while I will not ask for funds to attend outside meetings, which I agree make it appear that I represent the University, I will ask that they allow me to use funds to return to the University, as they have in the period since July 31. I will ask for compensatory damages. Should I indicate what damages? If so, funds to meet with and obtain materials from those who I have been forbidden from meeting, funds to access information that I have not been able to access by being at the University when I have wanted to be there.. Anything else?

I will emphasize the pack and ship thing more strongly.
