Richard can listen to =he mediator's introductory remarks and he can participate in =he discussion in "our room" during the shuttle =iplomacy of the mediator, as well as any discussions I have with you =nd Valeria during the mediation. Ordinarily non-lawyers do not =therwise participate, for example, if there are direct discussions =mong counsel.
