The Dean contacted me on the weekend and asked to have a phone meeting regarding conciliation this morning at 9. I also asked him about a statement to save face.. since that w=s my other condition in the conciliation process.. namely to restore my rep=tation to some extent. He said he thought the university would come out with a brief statement saying I had decided t= retire.. So basically, his first offer is nothing at a=l..

I am going to come up with a counter proposal and will give it to him on Wed and we will see what happens or whether we have to move forward to the next step.
