Morning Richard,

I'm awaiting a vendor response concerning a Lithium Ion storage option but =have received some preliminary information I'd like to share.

There is a Nickel Iron battery option =hich has been the mainstay for the the Nissan Leaf and other electric =ehicles.

This has a 30+ year life expectancy (11,000 Cycles @ 80% depth of discharge) and is compatible with all of the supporting infrastructure i.e. SMA inverters. chargers, etc.. Unfortunately there is a 4 month lead time for delivery.

The initial "turn key" cost analysis =or this system is \$347,958.00. This is prior to any offsets.

I'll continue to pursue options but =ppreciate any feedback as we move forward.
