My po=icy was to simply say oh.. let me consider this, can we talk again.. and we agreed to talk again on Wed. I asked abou= money, and he was unclear, although he said if I retired he thought I wou=d get whatever retirement package there is.. which of course is nothing, a=d said he didn't think the university would be willing to give money (which goes against what the conciliation c=mmittee said he said when they met him, so maybe he simply doesn't=know). I also asked him about a statement to save face.. since that =as my other condition in the conciliation process.. namely to restore my reputation to some extent. He said he thought t=e university would come out with a brief statement saying I had decided to=retire.. So basically, his first offer is nothing at a=l..

I am going to come up with a counter proposal and will give it to him =n Wed and we will see what happens or whether we have to move forward to t=e next step.
