- \* Ashford Hospitality Prime is a Maryland REIT that is externally managed by Ashford, Inc, a publicly-traded asset manager
  - \* In April 2018, Ashford Hospitality Prime was re-branded to Braemar Hotel & Resorts (NYSE: BHR)
  - \* While hurricane repairs are underway it is named 'Great Bay Resort' hotel under the Fairfield Inn & Suite brand.
- \* Yes, the Ritz was considered the best run on the island, probably followed by Frenchman's Reef (owned by DiamondRock Hospitality and managed by Marriott International).</span>

\* Bought by Interval Leisure Group in October/November 2015 when it purchased Vistana Signature Experiences (Starwood Hotel's vacation ownership portfolio)  
\* Interval Leisure is acquired by Marriott Vacation's Worldwide in August 2018 (they own a property next to Frenchman's Reef)

\* Acquired by CBI Acquisitions, LLC in 2004  
\* Key member is Gary Engle, CEO & Chairman, of Stoneleigh Capital  
\* Unaffiliated since they let the Rosewood management agreement expire in August 2013 and re-established a relationship with Leading Hotels of the World  
\* Trying to get a new lease agreement with the National Park through Congress before they invest in the property. Stacey Plaskett has been instrumental in pushing the new lease through Congress.  
\* The closest resorts to AYH are Sugar Bay which is privately owned and managed. It is not presently open to the public. Margaritaville is also in Smith Bay but it's a vacation ownership property. There are also Point Pleasant, Secret Harbor at the Elysian but they are all vacation ownership properties as well. Nothing near AYH is on the scale of the Ritz.
