b. Except as provide= in ABOR Policy 6-201J.3.c (Conditions of Faculty Service, Dismissal or Suspens=on, Leave with Pay), the decision to place a faculty member on leave with pay:<=div>

- (1) M=y be made only after the faculty member has been provided an opportunity to res=ond to the allegations; and
- (2) Shall be promptly communicated in writing to th= faculty member.

c. In exceptional cases, when the president makes a written finding=/div> that=release of information relating to the substance or source of the allegations m=y compromise the investigation of such allegations, the university may limit or=deny the faculty member's opportunity to respond to the allegations for a p=riod of time not to exceed fifteen (15) working days while the investigation pr=ceeds.
