Hi Jeffrey,

It seems Vincent's deadline is Today, September 4. He has to file the response tomorrow.

He seems to be eager to talk to Richard, as he needs some information. —

I explained to Vincent that Richard was getting very limited information from Max and from Bain. And that this was part of our problem. But Vincent thinks Richard still can help.

According to Vincent, in the meeting with Deborah, she told him that the reason Max wanted the financial investigation was because Noam had requested \$500,000 from the Marital Trust. Deborah and Max inverted the order of the facts.
