In the meantime, the only other thing I was planning to do re the case was draft an inquiry letter to Australian solicitors, as per your recommendation last week, to see whether a defamation suit here against Melanie Thomson would fly. That was my task for an hour this morning. And then I will move on to preparing a talk for Mexico next week.
