The Dennis Tracey subs are designed to=require very little air movement (see photos below).<=p>

With regard to the curtain, we need to=talk a little more, but we should make a "foldable) 3 / 4 panel ½ bulkhead that attaches to the arm rest cabinet with rare earth magn=ts. Use nomex composite for rigidity. We can discuss the foam, fabri=, etc. over the phone. Please do not say mirror the bedroom side =80 .

There is a foam membrane to "seal=E2 the sub with the only area for air movement is approx.. .50 =9D high x 2.00" wide (either side of the one mounting bracket)=u>
