Jeffrey,

Maurice had a better idea for the subwoofer.

Right now, the tray that holds your bag(s) sits about .50" or so above the carpet. If we increase the gap between the bottom of the tray and the carpet another 1.5", we could install the subwoofer close to its original position in the aircraft (as originally designed). This would leave a 2.00" space under the tray vs .50".

Personally, I believe this is a better idea.
