My apologies for the delay in responding to your emai=. Please be assured that I will work as quickly as I can to investigate the claims that you made during our meeting on Tuesday. I believe t=at Pedro forwarded the pictures, as we discussed.

Please be advised that it has been brought to our att=ntion that there is still activity happening on Great St. James. On J=nuary 30, 2019, we received a report from Enforcement stating that they saw=machinery moving stuff around on the shore on the Christmas Cove side of the island. Enforcement also spot=ed what looked to be a barge delivering a dump truck to the island. As we d=scussed in our meeting, the C&D is still in place until we have resolve= the questions of the permits, and repair work is required to be reported to the Department. One purpose of these pol=cies is to ensure that any work is being done in a way that would have mini=al adverse effects on the environment. As Pedro mentioned in our meeting, n= Best Management Practices were put in place for any of the activities done on the island. = The exclusion of BMP's can result in additional citations.&n=sp; Please note that marine impact may constitute a federal offense if any p=otected Endangered Species Act species are observed in the impacted area. Amy Dempsey could provide further information on this topic.

We trust that you will notify your client of what we d=scussed so that he can avoid any further issues with the department. I=will notify you of what I find regarding the permit issue.
