Sir,

The floors have been wet=from the floor guys adding coats to the floor, thus the limitation of access for Reefco. It can't be walked on when wet.

A scratch is in the floor of the master from when our guys moved furniture out. The flooring guys tried to fix and coat over it, but it is still=visible. Luis said the only way to fix it is to sand the floors uniformly =ack down, then start over with the polyurethane. Do you want me to have them fix it? If so, then completion of the master will be delayed by at least a week. If not, we can put the=master back together Monday and get Reefco back in ASAP. I believe they'll need three days.

Also, I asked Luis about the discoloration around the edge=. He said this is caused by moisture condensation in the walls (the walls =re sweating due to temperature variances from outside to inside). He said =hey have a matching paint that they can use to go around the edges with a =hin line to blend this in. Again, this will take more time.
