Excerpts from [REDACTED] March 15, 2005 recorded interview with Detective [REDACTED]

[REDACTED] told Detective [REDACTED] that she lied to J= that she was 18 years old and was told that she had to or would not be allowed into his home:

know how old you were?

Okay. Yes. And, as a matter of fact, Haley told=me to say I was 18, because Haley said tell him you're 18 because if you're not, he won't let you in his house. So I said he was 18. [REDACTED] also told the Detective that [REDACTED] left her telephone number for JE after her encounter with him:

[REDACTED] Did you leave a phone number?

[REDACTED] Yeah. Act=ally I did. Cause when I was leaving, he goes um, please leave your <=span>phone number so Haley can keep in touch with you because she doesn't have your phone number. So I didn't, I just gave him my cell phone number. I didn't give him my house number, I gave him my cell phone number.
