Jeffrey – Leon asked me to ask you. Debra is going to Chicago May 30th =96 back and forth the same day. Here is the response from Jet

Hi Melanie,

For May 30th with the 12pm departure out of Teterboro and 11pm departure ou= of Chicago the duty day is at 15hrs18min. For 135 trips crew cannot exceed 14hr duty day. If you wish to operate this flight as 135 we must do a crew swap in Chicago. If we were to operate this fight as 91 with a Chief Pilot= approval we could extended the duty day to 16hrs. Please let me know how =ou wish to proceed.

Can we switch to 91 – Here is what they said about the difference:

When operation 91 the owner has operation control and we have a little bit =f flexibility with extending the duty day as long the chief pilot approves=it.

When operation 135 its consider business and the rules are a lot stricter. =e are not able to extend the duty day. Two pilots can only be on duty up to 14hrs and no more than 10hrs of flight time.
