The idea is simple: massage therapists demand with a focus on tech companies with 50-500 employees. I've spoken with some office managers/HR people who are responsible for employees' "happiness", they seem to be keen on the idea of offering massage to their employees. I'm in a process of creating web and mobile application to look credible and collect useful feedback. I have one-committed male masseuse and I'm looking into how to lure female ones.

Unfortunately, I stopped traveling for bridge tournaments (or any traveling for that matter) because my budget doesn't allow it. I still have passion for the game and once I save enough, I'll resume my participation.
