Dear Leon,

I am happy to say I was able to improve our offer a little bit, if not to the level you had hoped.

Our best and final offer is a guarantee of \$18,750,000 with an 80/20 split in your favor. Estimate will be £15-25M (assuming pound conversion does not change significantly).

We are massively enthusiastic and eager for this work for the June London Sale. It will be on exhibition here in New York during our May Sale exhibition to take advantage of the collecting audience in town. Please find attached the full marketing plan for this work.
