Arm rests - Perhaps I was not clear last night. Yes, we can increase the width of the arm rests (the whole arm rest), aside from the modification work, there will simply be an additional cost for the engineering certification of the arm rests / seat assembly.

I suspect that the 650 seat is proprietary to Gulfstream. If you like the look of that seat, we can modify your seats to look extremely similar – with the only exception being the angled front end of the arm rests.

I really like that "undermount 80 rectangular sink for the aft lav vs. the tall, clunky "overmount" sink.
